- 4. Please note that nomination papers MUST be received within the statutory timescales stated and hand delivered only or they will not be accepted. Nomination papers received through the post or by electronic means will NOT be accepted and will be deemed as not received in the prescribed manner.
- 5. If the election is contested the poll will take place on Thursday 12th March 2020.
- 6. Applications for postal and postal proxy votes must reach the Electoral Registration Officer at Electoral Services, Wiltshire Council, County Hall, Bythesea Road, Trowbridge, Wiltshire, BA14 8JN by 5pm on Wednesday 26th February 2020.
- 7. Amendments or cancellations to existing postal, postal proxy and proxy votes must reach the Electoral Registration Officer at Electoral Services, Wiltshire Council, County Hall, Bythesea Road, Trowbridge, Wiltshire, BA14 8JN by 5pm on Wednesday 26th February 2020.
- 8. Applications to vote by proxy at this election must reach the Electoral Registration Officer at Electoral Services, Wiltshire Council, County Hall, Bythesea Road, Trowbridge, Wiltshire, BA14 8JN by 5pm on Wednesday 4th March 2020.
- 9. A person can apply to vote by 'emergency' proxy if they learn they cannot go to the polling station because of their occupation, service or employment, or a medical condition, illness or disability arises after 5 pm on Wednesday, 4th March 2020. The application must reach the Electoral Registration Officer at Electoral Services, Wiltshire Council, County Hall, Bythesea Road, Trowbridge, Wiltshire, BA14 8JN by 5pm on Thursday, 12th March 2020.
- 10. Parish/Town Councils must decide whether poll cards are sent when an election is requested and a poll is held. It is not a legal requirement to send poll cards.
