The Clerk has sent the details to WC Highways and if one particular setting is not used the device is acceptable for use. The locations must have had a traffic survey and there must be evidence of speeding, currently only The Avenue has had a survey with results showing a speeding issue. Due to the road a device on the Avenue can only be put up / taken down by an approved streetworks contractor. The Clerk has made enquiries as to who could do this and what the charge would be. The other sites may require a new traffic survey and therefore the locations need to be agreed. Would the Council wish for the device to be purchased before the sites have been agreed or wait until it is confirmed the device can be used.
