Nature of Issue: (Max 600 characters) The upper section of North Street (West Street to Churchill Crescent) is 1-hour limited parking with no resident exemption, while lower parts and nearby car parks are already heavily used. Many homes here and in nearby streets (Wiley Terrace, Riverside, Northleigh Terrace) have no off-street parking, so residents cannot reliably park near their homes. Several vehicles are left on the street for months at a time, in visibly poor condition, and appear to be untaxed or without an MOT, further reducing the already limited parking space.		
How long has it been an issue?	This has been a long-standing problem. Neighbours report it has been an issue for at least 10–20 years	
What would you like done to resolve this issue? (Max 600 characters) I would like Wiltshire Council to review parking on North Street via LHFIG and the Area Board. Specifically: <ul style="list-style-type: none">Survey parking demand/occupancy on North Street and adjacent streets.Allow residents' permits/exemptions in the existing 1-hour bays between West Street and Churchill Crescent (excluding the Market Place car park).Consider a wider residents' parking / shared-use scheme for the central streets so residents with no off-street parking have a fair and safe chance to park near home.Improve local public transport and cycling links in the area to encourage less car use

- Clear away all builders rubbish on completion.


